#### **Job Description**

Position: Spa Shift Supervisor

Reports to: Spa Director

#### Purpose of the Position:

 To provide floor level supervision and support to a team of Spa Therapists while also regularly performing Spa Services

#### **Key Objective # 1**

To lead by example and provide a high quality of service and rate excellent on guest surveys

### **Typical Activities**

- To be polite and professional at all times
- To be knowledgeable in all treatments that Ste. Anne's offers
- To greet all guests and maintain eye contact when speaking with them
- To be knowledgeable about the property and surrounding area
- To appear for work according to the dress code policy

### **Key Objective #2**

To ensure smooth daily operations in the spa department

### **Typical Activities**

- Prepare the day for the arriving therapists before 8:30 am
- Check staff schedules, and identify any potential issues (eg. gender requests, mobility issues)
- Assist therapists who may be running behind with room set up, clean up etc.
- Assigning tasks to the spa therapists during any downtime as it occurs
- Monitor hallways to ensure staff are being productive and guests are able to enjoy a
  quiet spa experience.

#### **Key Objective #3**

Monitor treatment rooms for equipment maintenance, décor, and cleanliness

### **Typical Activities**

- Perform weekly inspections of all spa equipment to ensure it is in good repair
- Monitor room cleanliness and identify issues weekly
- Make recommendations for changes and updates monthly or as required



### **Key Objective #4**

#### Become the lead in-house trainer for Ste. Anne's Skin Nourishment Product Line

### **Typical Activities**

- Learn the Skin Nourishment product line inside out, including attending all training sessions
- Organize all SN training for new and existing staff or as updates are required for new products monthly
- Be the go-to person for frontline and spa staff for questions or concerns related to the line

### **Key Objective #5**

**Assist Spa Director with Coaching and Performance Reviews** 

#### **Typical Activities**

- Perform therapist assessments when requested
- Assist with therapist coaching when necessary
- Provide additional insight on Therapists performance for consideration
